

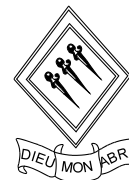


### Student's Data Protection Waiver

In order to provide and process a work experience placement, St. Bernard's High School requires some specific information. Some of this information we are required to pass onto the employer so that they can provide a suitable experience and do everything that is reasonably practicable to protect the Health, Safety and Welfare of Students. The information we require is as follows:
